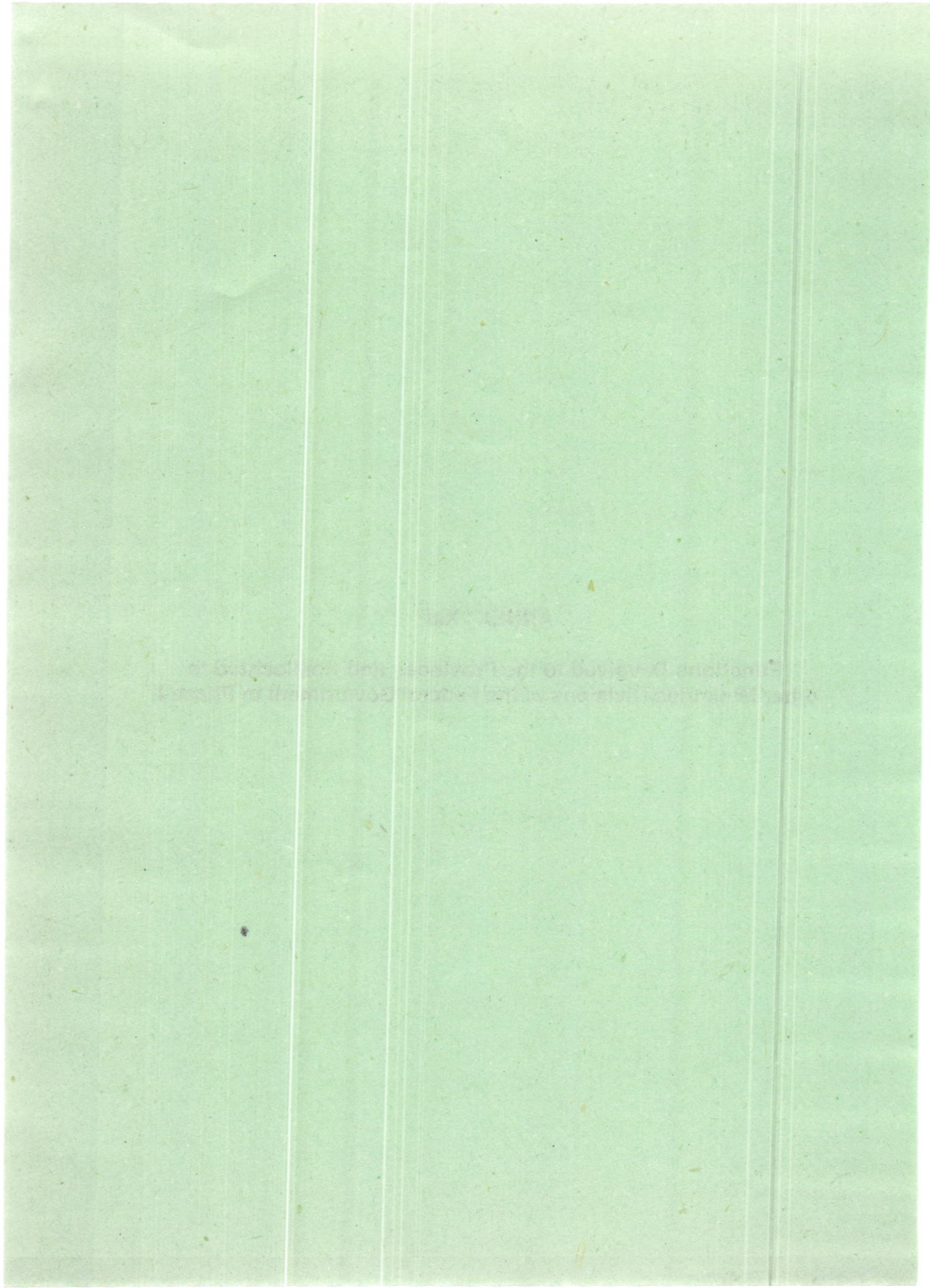

other Ministries/Divisions of the Federal Government in Phase-II**

NOTIFICATION

No. 4-5/2011-Min.I.—Consequent upon the deliberations / decision of the Implementation Commission, constituted under clause (9) of Article 270AA of the Constitution and with the approval of the Cabinet, a new Division, namely “**Capital Administration and Development Division**” has been created, under the “**Cabinet Secretariat, with immediate effect.**”

2. The aforesaid new Division shall execute, within the jurisdiction of the Federal Capital Area, all such functions handled by the abolished / would be abolished Ministries/Divisions, and also such other functions as allocated to it henceforth with and from time to time. The functions/Departments/organizations allocated to the new Division, shall include:

- (i) Academy of Educational Planning & Management, Islamabad,
- (ii) Animal Quarantine Department / Stations / Facilities, in Islamabad,
- (iii) Central Board of Film Censors, Islamabad,
- (iv) Charitable endowments for Federal Area,
- (v) Department of Archaeology & Museums, Islamabad,
- (vi) Department of Libraries,
- (vii) Department of Tourist Services in Islamabad,
- (viii) Directorate General of Special Education, Social Welfare, Child Welfare & Development, Islamabad

- (ix) Federal Board of Intermediate & Secondary Education (FBISE), Islamabad,
- (x) Federal College of Education, Islamabad.
- (xi) Federal Directorate of Education (FDE) and Education in the Capital (of Federation),
- (xii) FG Polytechnic Institute of Women, Islamabad,
- (xiii) Mainstreaming population Factor in development planning,
- (xiv) Management & Distribution of Zakat and Usher in Islamabad,
- (xv) National Education Assessment Centre, Islamabad,
- (xvi) National Institute of Science & Technical Education (NISTE), Islamabad,
- (xvii) National Veterinary Laboratory, Islamabad,
- (xviii) Private Educational Institutions Regulatory Authority,
- (xix) Training and education and rehabilitation of disabled in Islamabad,
- (xx) Youth Centres & Hostels in Islamabad,
