**OPEN AUCTION OF USED VEHICLES**

Government of Pakistan Ministry of Inter Provincial Coordination intends to auction following used vehicles of closed Projects / Programmes on "as is and where is basis" on **22<sup>nd</sup> July, 2019 at 10:00 A.M** at the parking area of Cabinet Block, Islamabad

The vehicles, parked in the Cabinet Block and workshop at Blue Area, Islamabad can be inspected during 10:00 A.M. to 12:00 Noon from 4<sup>th</sup> to 19<sup>th</sup> July, 2019.

**Terms of Auction:-**

- a) Interested bidders are required to submit an attested photocopy of his CNIC alongwith a pay order amounting to Rs. 50,000/- (Refundable) in favor of DDO, M/o IPC on or before 22.07.2019 at 09:30 AM in the office of Section Officer (General) without which nobody will be allowed for taking part in the auction.
- b) The pay order of the unsuccessful bidders will be returned after completion of the auction on the same day.
- c) Only the bidders who have deposited the required pay order shall be allowed to enter in the auction premises. The entry of unauthorized people shall not be allowed.
- d) The bidders must bring their original CNIC and provide complete address / telephone numbers and attested copy of CNIC on the day of auction.
- e) Successful bidder must deposit earnest money i.e. 20% of the bid in cash at spot and the remaining amount must be deposited within three days after auction. In case of default earnest money will be forfeited.
- f) It may be noted that no Registration Books / Papers are available of aforesaid 12 vehicles as these vehicles were transferred to this Ministry from closed Projects / Programmes without documents. Therefore, the bidders will be responsible to make payment of registration charges to the concerned Excise and Taxation Office for issuance of duplicate registration books, outstanding token taxes alongwith penalties in the first instance, and then have to pay all charges for issuances of new registration book and number of vehicle. Besides, the successful bidders will be responsible to pay any other outstanding dues of the vehicle.
- g) Successful bidders will have to remove the vehicles after full payment and getting the registration of vehicles in his name, at his own expenses, within ten days after making payment.
- h) The transfer of ownership documents would be the responsibility of the successful bidder.
- i) Taxes (if applicable) shall be as per prevailing law.
- j) Competent Authority reserves the right to accept or reject any or all bids, partially or fully, without assigning any reason.
