

4. Single stage-one envelop procedure as contained in Rule 36(a) of PPR, 2004 shall apply. Sealed bids supported by earnest money, earmarked above in the shape of Pay Order / Demand Draft/Call Deposit in favour of DDO, M/o IPC should reach the M/o IPC on / or before 10:30 A.M by 9th July, 2021.
